The Coalition is a membership organization and provides on-going quality training and support to its members. This revised calendar offers members important dates and relevant information for 2010. It is divided into three sections: Statewide and Circuit Trainings, Regional Meetings, and Important Dates. We look forward to seeing you in 2010!

Statewide and Circuit Trainings (page 2)

Statewide and circuit trainings are open to members across the state. They are an opportunity to stay informed of best practices, develop new skills, gain knowledge, learn and connect with leaders from across the country, and network with members and Coalition staff. Statewide trainings host national speakers and Coalition staff as presenters and cover a range of topics. The Professional Development Series started in 2009 and allows members to receive highly interactive, more intimate training at the MCADSV Training Center. During 2010, two trainings, for legal and economic advocacy, will be taken around the state in a "circuit." Brochures with more detailed information are mailed about six weeks before each training.

Regional Meetings (page 3)

Bi-monthly regional meetings cultivate relationships and promote communication between its members. These meetings are an opportunity for Coalition members to network, share ideas, problem-solve, discuss Coalition activities and announcements, and receive training. Program Development Specialists (PDS) and Regional Representatives help facilitate meetings. PDS are Coalition staff members who are assigned to the regions to work with programs regarding capacity-building, quality assurance and best practices. Regional Representatives are MCADSV Board members working on behalf of their regions during Board meetings and strategic planning.

Members may attend any of the regional meetings but will receive notices for only the region to which they are assigned. Postcards with more detailed information are mailed four to six weeks before each regional meeting.

Important Dates (page 4)

New to the calendar, this section details important dates for each month. These include statewide and circuit training, regional meeting dates, Regional Legislative Advocacy Days (RLAD), Coalition membership and Board of Directors deadlines, Monthly Services Reports and Outcomes deadlines, and core domestic and sexual violence grant timelines.
