KNOW YOUR RIGHTS

Under the Sexual Assault Survivors' Bill of Rights

1. This section shall be known and may be cited as the "Sexual Assault Survivors' Bill of Rights." These rights shall be in addition to other rights as designated by law and no person shall discourage a person from exercising these rights. For the purposes of this section, "sexual assault survivor" means any person who is fourteen years of age or older and who may be a victim of a sexual offense who presents themselves to an appropriate medical provider, law enforcement officer, prosecuting attorney, or court.
2. A sexual assault survivor retains all the rights of this section regardless of whether a criminal investigation or prosecution results or if the survivor has previously waived any of these rights.

A sexual assault survivor has the right to:

- (1) Consult with an employee or volunteer of a rape crisis center as defined in Section 455.003;
 - (2) A sexual assault forensic examination as provided in Section 595.220, or when a telehealth network is established, a forensic examination as provided in Section 192.2520 and Section 197.135;
 - (3) A shower and a change of clothing, as reasonably available, at no cost to the sexual assault survivor;
 - (4) Request to be examined by an appropriate medical provider or interviewed by a law enforcement officer of the gender of the sexual assault survivor's choosing, when there is an available appropriate medical provider or law enforcement official of the gender of the sexual assault survivor's choosing;
 - (5) An interpreter who can communicate in the language of the sexual assault survivor's choice, as is reasonably available, in a timely manner;
 - (6) Notification and basic overview of the options of choosing a reported evidentiary collection kit, unreported evidentiary collection kit, or anonymous evidentiary collection kit as defined in Section 595.220;
 - (7) Notification about the evidence tracking system as defined in subsection 9 of Section 595.220;
 - (8) Notification about the right to information pursuant to subsection 4 of Section 610.100;
 - (9) Be free from intimidation, harassment, and abuse in any related criminal or civil proceeding and the right to reasonable protection from the offender or any person acting on behalf of the offender from harm and threats of harm arising out of the survivor's disclosure of the sexual assault.
3. An appropriate medical provider, law enforcement officer, and prosecuting attorney shall provide the sexual assault survivor with notification of the rights of survivors pursuant to subsection 2 of this section in a timely manner. Each appropriate medical provider, law enforcement officer, and prosecuting attorney shall ensure that the sexual assault survivor has been notified of these rights.

2. Un sobreviviente de agresión sexual conserva todos los derechos de esta sección, aunque se lleve a cabo una investigación o un procesamiento penal o el sobreviviente haya renunciado previamente a alguno de estos derechos.

Un sobreviviente de agresión sexual tiene derecho a:

- (1) Consultar con un empleado o voluntario de un centro de crisis por violación, como se define en la sección 455.003.
 - (2) Un examen forense de agresión sexual, según lo dispuesto en la sección 595.220, o cuando se establece una red de telesalud, un examen forense, según lo dispuesto en la sección 192.2520 y la sección 197.135.
 - (3) Una ducha y un cambio de ropa, según sea razonablemente posible, sin costo para el sobreviviente de la agresión sexual.
 - (4) Solicitar someterse a un examen con un proveedor médico adecuado o ser entrevistado por un agente de la ley del sexo que elija el sobreviviente de la agresión sexual, cuando haya un proveedor médico disponible o un agente de la ley del sexo que el sobreviviente de la agresión sexual prefiera.
 - 5) Un intérprete que pueda comunicarse en el idioma de la elección del sobreviviente de una agresión sexual, según esté razonablemente disponible, de manera oportuna.
 - (6) Recibir una notificación y un resumen básico de las opciones para elegir un kit de recolección probatoria informada, un kit de recolección probatoria no informada o un kit de recolección probatoria anónima, según se define en la sección 595.220.
 - (7) Recibir una notificación sobre el sistema de rastreo de evidencias, según se define en la subsección 9 de la sección 595.220.
 - (8) Recibir una notificación sobre el derecho a la información de conformidad con la subsección 4 de la sección 610.100.
 - (9) Estar libre de intimidación, acoso y abuso en cualquier procedimiento penal o civil relacionado y derecho a contar con protección razonable contra el agresor o cualquier persona que actúe en nombre del agresor y contra amenazas de daño a causa de que el sobreviviente revele la agresión sexual.
3. Un proveedor médico correspondiente, un agente de la ley y un fiscal proporcionarán al sobreviviente de agresión sexual una notificación de sus derechos de conformidad con la subsección 2 de esta sección de manera oportuna. Cada proveedor médico correspondiente, agente de la ley y fiscal debe asegurarse de que se notifiquen estos derechos al sobreviviente de una agresión sexual.
